Lot 14, Exc NWly 6 Ft Thereof, All of Lot 15, B 13, together with the NWly 6 Ft of Front St Vacated by order of Hermie Herie, County Commissioner, Vol 31 at Page 55 of Commissioners' records, abutting upon and attached to said lots.

Lot 1, Exc NWly 6 Ft thereof, and all of Lot 16, B 13, together with the Buildings of the 2nd Class so conveyed by the State of Washington, to the Mean Lot Line in Front of and adjacent thereto. All in the plat of PLAT OF THE TOWN OF ARTENA, Pierce County, Washington, according to plat recorded in Book 5, Plat, Page 6.
