

## ORDINANCE NO. 1411

### AN ORDINANCE OF THE CITY OF GIG HARBOR, WASHINGTON, RELATING TO THE CITY'S 2019 BUDGET, ADDING ONE POSITION AND RECLASSIFYING ONE POSITION FOR THE 2019 BUDGET.

---

WHEREAS, in mid-January, 2019, the City Council and City staff analyzed the benefits and cost-savings of hiring a City Attorney in lieu of contracting with a firm for legal services; and

WHEREAS, Council adopted Ordinance 1410 on February 25, 2019, providing for the appointment of a City Attorney and outlining the duties of the City Attorney; and

WHEREAS, the City has hired a Community Development Director to oversee all Planning, Building and development review functions; and

WHEREAS, the Building Official/Fire Marshal is proposed to manage the Building Division of the Community Development Department; and

WHEREAS, the Planning Division of the Community Development currently does not have a manager; and

WHEREAS, the City intends to reclassify an existing and budgeted Senior Planner position to a Principal Planner; and

WHEREAS, adequate funds exist in the City's anticipated 2019 ending fund balances for the general fund in order to fund this position;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GIG HARBOR, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Attachment "A" of Ordinance 1402, which adopted the 2019 Budget, shall add the following positions and 2019 salary ranges:

Principal Planner	7,322	9,153

Section 2. Severability. If any section, sentence, clause or phrase of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, clause or phrase of this Ordinance.

**Section 3. Effective Date.** This Ordinance shall take effect and be in full force five (5) days after passage and publication of an approved summary consisting of the title.
