### **City of Gig Harbor State Legislative 2017-19 Legislative Agenda Revised for 2018 Legislative Session**

#### **Capital Funding Request: Gig Harbor Sports Complex**

The City supports the passage of the 2017-2019 Capital Budget that includes funding for the Gig Harbor Sports Complex (7/20/17 version included \$206,000). Moving forward, the City requests funding for the ongoing development of the 17-acre sports complex with improvements to include a turfed and lit baseball and multi-purpose sports fields to meet the needs of our rapidly growing community. The project has multiple partners including the Pierce/Kitsap YMCA, Gig Harbor Little League, Peninsula Light Company and Olympic Property Group. Local funds are available and a master plan will be developed as approved by the Parks Commission and Public Works Committee.

#### **Transportation Funding: West Sound Alliance**

The City supports the West Sound Alliance in continuing to seek transportation funding for the West Sound region. In particular, the city will closely follow the progress of the congestion relief study for State Route 16, the completion of the EIS on State Route 302, and advocate for funding for resulting projects. Additionally, the City will actively lobby in support of policy and funding proposals that limit and reduce toll increases on the Tacoma Narrows Bridge.

#### **Support Main Street Legislation**

The City supports policy and budget decisions that increase funding for Main Street Tax Incentive Program. The Main Street Program was created in 2005 to support downtown revitalization programs. The Downtown Gig Harbor Waterfront Alliance participates in the program.

#### **Tourism**

The City supports the creation of a Tourism Marketing Authority that is funded with a revenue source that honors existing local lodging tax funding distribution methods.

#### **Infrastructure Funding**

The City supports the state's investment in the Public Works Assistance Account as a long-term program that provides infrastructure funding for local jurisdictions.

#### **Protecting State-Shared Revenues**

The City supports the continued appropriation of state-shared funds to local governments, including funds such as liquor excise taxes and profits, streamlined sales tax mitigation funding, the city-county assistance account, and the municipal criminal justice account. Additionally, the City supports legislation to restore growth to the liquor profit/fee revenues. Combined, these funds provide a significant amount of revenue to the City's general fund.

The City opposes legislation that removes local control in the siting and regulation of small cell network facilities. Furthermore, the City supports legislation that makes statutory changes to clarify and improve the deployment of small cell network facilities.

**Police Body Cameras**

The City recently equipped their police officers with body-worn cameras. The City supports legislation that removes the sunset on Public Records Act provisions of 2016 body-worn camera legislation to ensure transparency, accountability, and public safety.

**Use of Deadly Force**

The City supports efforts to fairly balance public safety, accountability, and adequate training of all officers.
