

RESOLUTION NO. 1063

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GIG HARBOR, WASHINGTON WAIVING THE REQUIREMENT FOR COMPETITIVE BIDS FOR PURCHASE OF WATER METERS, REGISTERS, SOFTWARE, HARDWARE AND TECHNICAL SUPPORT FOR THE CITY'S WATER DEPARTMENT.

WHEREAS, the City of Gig Harbor's Water Department desires to operate a water system with radio read meter technology; and

WHEREAS, the City has operated and maintained a water system utilizing Badger meters and related appurtenances for over 30 years as the utility standard in order to maintain consistency in inventory and operational knowledge, and

WHEREAS, the acquisition of new water meter reading equipment hardware and software must be compatible with existing infrastructure; and

WHEREAS, attached letter from Badger Meter, Inc. certifies General Pacific of Portland, Oregon is the sole provider of Badger products for the state of Washington; and

WHEREAS, the City's purchasing policy set forth in Resolution No. 593 authorizes the waiver of competitive bidding in the event the product comes from a sole supplier; Now, therefore,

THE CITY COUNCIL OF THE CITY OF GIG HARBOR, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Waiver of Competitive Bidding. As authorized by Section 2 of Resolution No. 593, competitive bidding is hereby waived for the purchase of equipment, software, and technical support for the City Water Department's metering system from General Pacific as the sole source of materials, equipment and services.
