**RE:** Temporary Sign Location of North Harborview and Vernhardson Street Intersection #6

#### **Background**

Temporary signs are allowed in specific locations around the city. These locations are identified by the directors' official temporary sign map (Exhibit A). Within these locations temporary signs must have approved sign permits. These permits are available to the public via our online permitting system. The permitting system allows you to choose the location. The location of North Harborview and Vernhardson is located on the directors approved Temporary Sign Map identified as #6. This location is a T intersection with residential properties to either side of the T.

#### **Concern:**

The city has received multiple calls from the residence to the west of this location. When exiting their driveway looking east at westbound traffic it is difficult to look through the signs. The area of the city right of way is elevated above the sidewalk making the height of the signs come in line with vehicles exiting the private driveway. This causes sightline traffic safety issues.

### **Staff Analysis**

Staff went out to the location and observed these concerns (Exhibit C). On both occasions on September 24, 2024, and December 4, 2024, while standing within the private driveway looking at oncoming westbound traffic staff observed the signs to cause a sight line issue. It is difficult to observe oncoming traffic without pulling your vehicle too far forward. On both occasions staff removed the signs.

### **Decision**

Staff have observed that the number 6 location, North Harborview and Vernhardson, where temporary signs are currently allowed, creates a traffic safety concern. Staff propose to remove this location from the director's temporary sign location map and online permitting system.

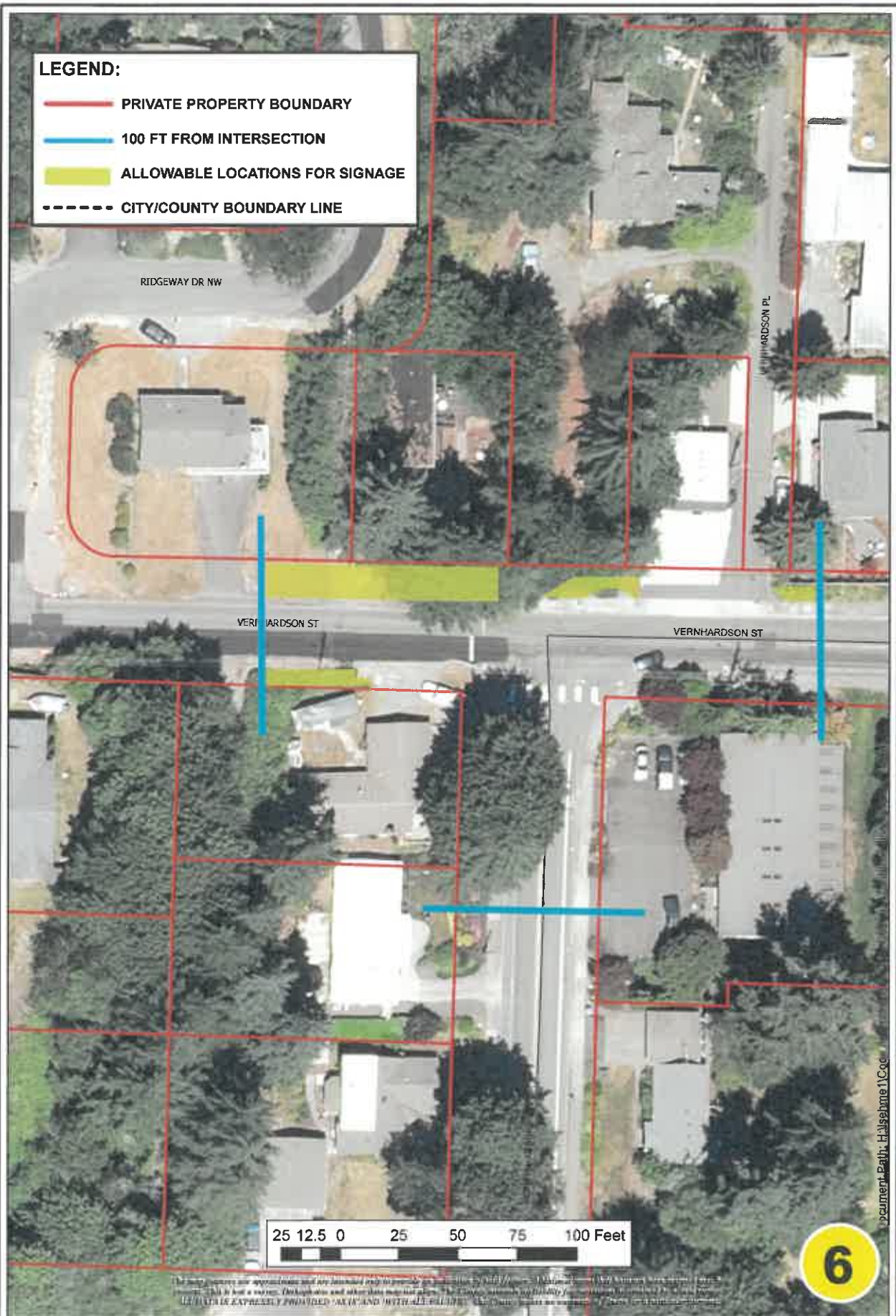

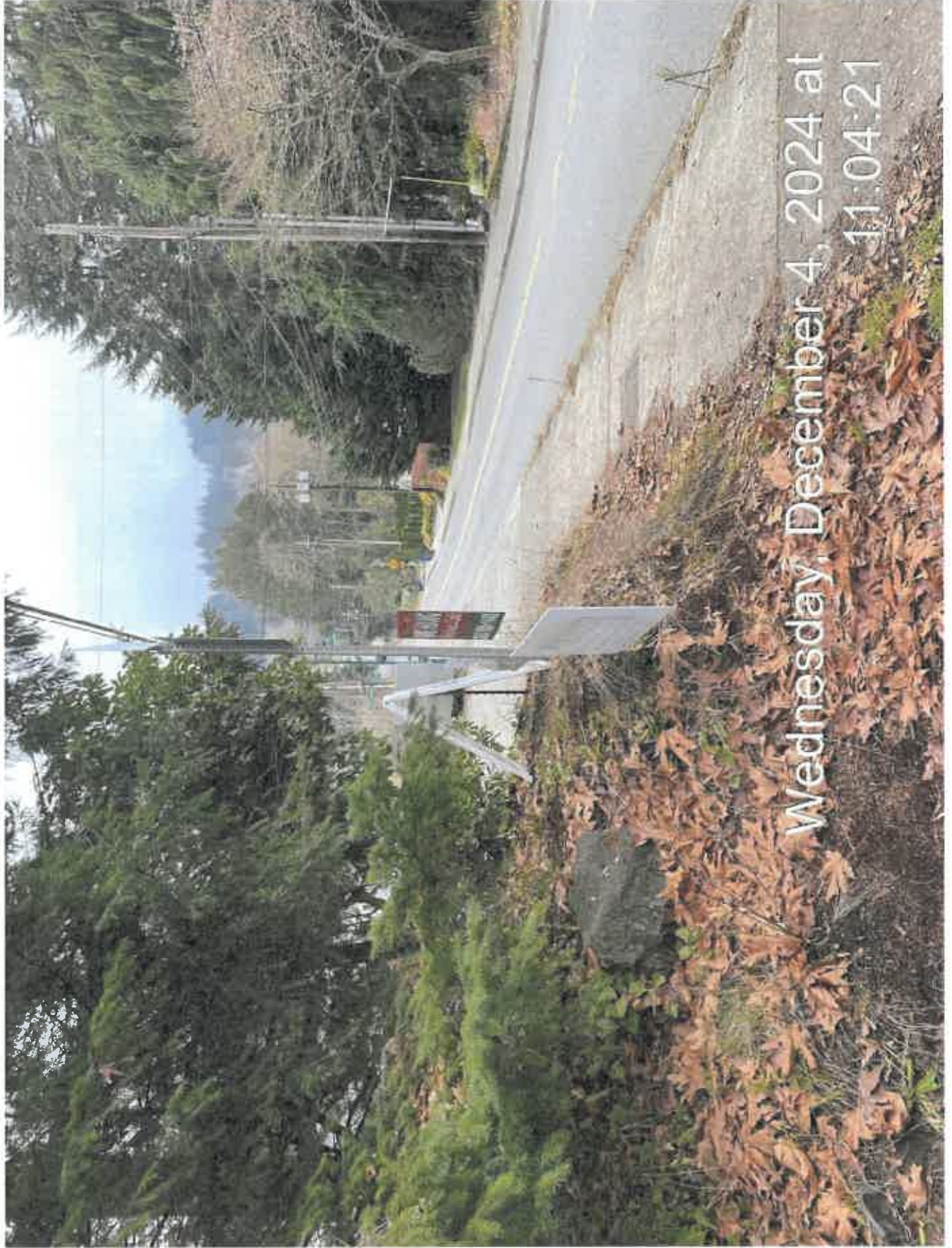
